

Motion for Relief from Stay – Self Scheduling

Court dates are available at WWW.VAWB.USCOURTS.GOV > Judges Info > Motion for Relief Dates

1. Choose a date that gives at least twenty (21) days' notice but not more than thirty (30) days' notice from the date of filing. File your motion electronically through ECF: *Bankruptcy>Motions>Relief from Stay*. Be sure to include your hearing information (date, time and appropriate location).

2. If filed outside of thirty (30) day notice requirement, then you must file a motion to extend stay through ECF (*Bankruptcy>Motions>Extend*). You will need to type "Stay" in white text box when prompted. You will also need to submit/upload a proposed order extending stay through ECF. *Bankruptcy>Order Upload> Motion Order Upload*.

3. If a motion is filed with a consent/agreed order, no hearing notice is necessary. File your motion electronically through ECF and submit/upload your consent/agreed order through ECF. *Bankruptcy>Order Upload> Motion Order Upload*.


