Request for Proposals Audio & Video Systems Open Market Lowest Price, Technically Acceptable

Special Notes:

This is a request for Open Market Pricing.

Statement of Work:

The Bankruptcy Court for the Western District of Virginia is requesting proposals for the replacement and upgrade of various audiovisual components in the U.S. Bankruptcy Courtroom in Roanoke, VA (location address: 210 Church Avenue, SW, Roanoke, VA 24011). All new components are to be integrated through a new Crestron interface with a new QSC audio system and an existing Polycom 700 group series video display system. All work must be approved by the court, comply with established standards, and meet all local building codes. Source code and Xpanel interface must be provided to the court upon completion of the project. This project addresses concerns in these areas: video conferencing, audio, evidence presentation, and Crestron control.

Video Conferencing details:

Existing Polycom (RealPresence 700) video conferencing system will be used and be integrated into the new Creston controls. The new Crestron system must be capable of receiving input from three existing Polycom Eagleeye 12x cameras as well as an input from the lectern evidence systems. The three existing Polycom 12x PTZ HD cameras will be wall mounted and placed in various areas of the courtroom and must be compatible with existing Polycom system and the output will feed AV scaler/distribution system capable of driving both the existing flat panel TV's, as well as 9 new 22 inch flat panel monitors (HDMI). Both existing flat panel TV displays and the new 22" Monitor displays will need to be moved and pole/wall mounted to various locations within the courtroom designated by the IT manager. Monitor displays will have the capability to display output from various court inputs.

Evidence Presentation details:

An AV scaler/switcher shall be installed in the lectern and integrated into the Crestron controls. It shall be capable of accepting VGA, DVI, HDMI, and composite video while integrating any audio accompanying each signal. The output will be sent to the AV scaler/distribution listed in the above paragraph. There shall be an appropriate patch panel that is user accessible for the inputs. A new Visual Document camera (Elmo P10HD or equal) is also to be installed in the lectern area. Modifications to the lectern furniture will be needed so that the document camera can slide out from the side of the lectern. Also, lectern will need to accommodate Crestron equipment placed in the bottom of the unit.

Crestron Control details:

Vendor shall install a Crestron control head at the Courtroom Deputy location and integrate all audio, video, and evidence throughout the court room. The final layout of the controls should follow closely what is already in place but may vary at the court's discretion.

Vendor will also move all new cabling to the first floor server room in an existing data rack.

Additional Technical Proposal Submission Requirements:

<u>Substitutions.</u> Brands and models of equipment mentioned above are products that meet the project requirements. Substitution of this brand name equipment with equal products is allowable unless otherwise indicated in the design. Proposals offering equal products will be considered for award if those products are clearly identified and are determined by the court to contain all of the essential characteristics of the brand name products referenced in the RFP.

If the contractor proposes to furnish an equal product, the contractor will provide all descriptive material (such as cut sheets, illustrations, drawings, or other information) necessary for the court to determine whether the substitution meets the requirements of the RFP.

Submit a technical proposal describing your approach, project management plan, and project cost(s) broken down by tasks in accordance with the statement of work listed above. Proposals are due by August 21, 2019 at 3:00 pm local time at the U. S.
