- 2. If filed outside of thirty (30) day notice requirement, then you must file a motion to extend stay through ECF (Bankruptcy>Motions>Extend). You will need to type "Stay" in white text box when prompted. You will also need to submit a proposed order extending stay through cmorders@vawb.uscourts.gov.
- 3. If a motion is filed with a consent/agreed order, no hearing notice is necessary. File your motion electronically through ECF and your consent/agreed order through cmorders@vawb.uscourts.gov.
