The Amended Motion For Entry of Order (the "Motion") filed pro se by Ern Reynolds, Trustee (the "Trustee") of the Reynolds Living Trust (the "Trust") came on for hearing on February 22, 2011. The Motion seeks the authorization of the Court for the deposit into the Court of a Cashier's Check issued by JPMorgan Chase Bank, N.A., in the amount of \$22,392.48, denoting Katherine Winifred H. Stone as Remitter. After review of the Motion, the

underlying "Motion to Intervene, Interplead, & Prescribe Bond"(the "Intervention Motion") (docket entry no. 63), and the "Motion for Judgment" (the "Injunction Motion") (docket entry no. 81), and after due consideration of the arguments advanced by the Trustee at the hearing and in his pleadings, together with the Court's Memorandum Decision (docket entry no. 67) and Order Granting Motion For Relief From Stay (docket entry no. 68), the Court is of the opinion that the Motion should be denied because it has determined that both the Intervention Motion and the Injunction Motion should be denied and dismissed for the reasons stated in separate orders ruling upon such motions and there is no independent basis to justify the granting of the Motion. Accordingly, it is ADJUDGED and ORDERED that the Motion appearing at docket entry no. 80 in this case is DENIED and DISMISSED but without prejudice as to the filing of any similar motion in connection with any adversary proceeding which the Debtor or the Trustee may hereafter file if otherwise appropriate.
