

MOTIONS FOR RELIEF FROM STAY
Judge Krumm Cases Only

Instructions

1. Choose a date below that gives at least twenty (20) days notice but not more than thirty (30) days notice from the date of filing.
2. File your motion electronically through ECF: *Bankruptcy>Motions>Relief from Stay*. Be sure to include your hearing information (date, time and location).
3. If filed outside of thirty (30) day notice requirement, then you must file a motion to extend stay through ECF (*Bankruptcy>Motions>Extend*). You will need to type "Stay" in white text box when prompted. You will also need to submit a proposed order extending stay through cmorders@vawb.uscourts.gov.
4. If a motion is filed with a consent/agreed order, no hearing notice is necessary. File your motion electronically through ECF and your consent/agreed order through cmorders@vawb.uscourts.gov.
5. Any motion requiring extended hearing time; counsel must contact the Clerk's Office at 540-434-8327 Extension 218 for scheduling the motion for hearing.
6. If you have any questions about the dates listed below, contact the Clerk's Office at 540-434-8327 Extension 218 for assistance in scheduling the motion for hearing.
7. Choose court location according to venue where 341 meeting was scheduled. (341 meetings held in Woodstock and Harrisonburg ; motion would be scheduled for HARRISONBURG.
341 meetings scheduled in Staunton; motion would be scheduled for STAUNTON-See Notation below)
