

**MOTIONS FOR RELIEF FROM STAY**  
**Judge Stone Roanoke Cases Only**

Instructions

1. Choose a date below that gives at least twenty (20) days notice but not more than thirty (30) days notice from the date of filing.
2. File your motion electronically through ECF: *Bankruptcy>Motions>Relief from Stay*. Be sure to include your hearing information (date, time and location).
3. If filed outside of thirty (30) day notice requirement, then you must file a motion to extend stay through ECF (*Bankruptcy>Motions>Extend*). You will need to type "Stay" in white text box when prompted. You will also need to submit a proposed order extending stay through [cmorders@vawb.uscourts.gov](mailto:cmorders@vawb.uscourts.gov).
4. If a motion is filed with a consent/agreed order, no hearing notice is necessary. File your motion electronically through ECF and your consent/agreed order through [cmorders@vawb.uscourts.gov](mailto:cmorders@vawb.uscourts.gov).
5. Any motion requiring extended hearing time; counsel must contact the Clerk's Office at 540-857-2391 Extension 25 for scheduling the motion for hearing.
